### **Investment environment**

Yields on 10-year US Treasuries were up 15 basis points (bps) in August to reach highs of 4.36%, before settling at 4.11%. The Treasury yield curve steepened notably following Fitch's downgrade of the US's sovereign credit rating, supply concerns and the US economy's continued resilience. In the UK, 10-year bond yields rose 5 bps to 4.36%, while 10-year German bunds edged down 3 bps to 2.47%. China's local currency government debt performed well on the back of the People's Bank of China lowering interest rates, but the currency weakened. The Bank of England (BoE) hiked interest rates by 25 bps, while Chair Jerome Powell left the door open for further rate hikes at the US Federal Reserve (Fed)'s Jackson Hole meeting.

### Portfolio review

The fund posted a negative return in August.

The negative performance was largely driven by the fund's overweight position to US duration (interest rate sensitivity), and the general steepening of yield curves, given our overweight stance to Treasuries and gilts (which underperformed).

Within credit, we maintain a defensive stance given the late-cycle environment. Investment grade corporate bonds saw weaker returns due to their higher sensitivity to interest rates. The allocation to floating rate asset and mortgage-backed securities within the fund was beneficial.

## Manager outlook

Typically, sovereign bonds have tended to perform as central banks reach peak/terminal rates (ie. stop hiking interest rates), as the long and variable lags of monetary policy slow the economy down. Rates are restrictive with 10-year US real yields close to 2%. In the US, there has been unequivocal improvement on inflation by whatever metric you use, with 3-month annualised core inflation now at 3%. This will eventually feed into the Fed's real rate framework, prompting the central bank to consider cutting rates next year just to keep policy as restrictive as it is today. Corporate credit markets appear to not be pricing in a recession, be it shallow or severe, with credit spreads below historical averages and out of sync with key macroeconomic cycle indicators. We continue to position the portfolio with long duration and remain defensive from a credit standpoint.

### What are the risks specific to this fund?

## Investment policy

The Fund invests in bonds of any quality, including high yield (non-investment grade) bonds and distressed debt, of governments, companies or any other type of issuer in any country. The Fund may invest up to 30% of its assets in asset-backed and mortgage-backed securities (ABS/MBS), including up to 10% of which may be high yield (non-investment grade, equivalent to BB+ rated or lower). The Fund may invest up to 20% of its assets in China onshore bonds traded through Bond Connect. The Fund may invest up to 50% of its net assets in total return swaps.

Where investments are made in assets in currencies other than the base currency of the Fund, the Fund will seek to hedge those assets back to the base currency to remove the risk of currency exchange rate movements.

The Fund may also invest in other assets including contingent convertible bonds (CoCos), perpetual bonds, cash and money market instruments.

The Fund makes extensive use of derivatives (complex financial instruments), including total return swaps, with the aim of making investment gains in line with the Fund's objective, to reduce risk or to manage the Fund more efficiently.

The Fund is actively managed with reference to the Euro Short-Term Rate, as this forms the basis of the Fund's performance target. For currency hedged Share Classes, the rate that corresponds with the relevant Share Class currency is used as the basis of the performance comparison. The investment manager has complete discretion to choose investments for the Fund and is not constrained by a benchmark.
