At a glance

Performance*

The Fund returned 13.33%, the Index returned 10.75% and the Sector returned 12.57%.

Contributors/detractors

Cytokinetics and ImmunoGen were among the top positive performers. Conversely, Akero Therapeutics and Sarpeta Therapeutics detracted from relative performance.

Outlook

With the rate-hike cycle ending in the US, and innovation and merger and acquisition (M&A) activity accelerating, we believe biotech could be poised for a rebound.

Investment environment

- Biotechnology stocks rallied sharply towards the end of the year, outperforming the broader health care sector as the US Federal Reserve (Fed) signalled that its monetary tightening cycle may soon be over.
- A flurry of merger and acquisition (M&A) activity also buoyed the sector.
- In keeping with the risk-on backdrop, small- and mid-cap biotech stocks outperformed larger peers.

Portfolio review

Looking at individual holdings, Cytokinetics was the top positive contributor. The firm's lead drug candidate, aficamten, is a small molecule myosin inhibitor being studied for hypertrophic cardiomyopathy (HCM), a condition that causes a thickening of the heart muscle and restricts blood flow. Its share price soared after Cytokinetics reported positive phase 3 results for aficamten, which showed a statistically significant and clinically meaningful improvement in exercise capacity in patients. Big pharma has demonstrated interest in novel targeted therapies for cardiovascular disease (such as Bristol-Myer Squibb's \$13 billion acquisition of a rival drug in 2020), which has prompted market participants to speculate that Cytokinetics could be an acquisition candidate.

ImmunoGen also aided performance. The company's share price surged when AbbVie announced plans to buy it for \$10 billion, representing a 95% premium to the prior closing price. (Janus Henderson was among the top active holders.) ImmunoGen develops antibody drug conjugates (ADC), among the hottest areas of cancer research. One can think of an ADC as a precision-guided missile that brings chemotherapy directly to cancer cells with less collateral toxicity. Earlier this year, ovarian cancer patients taking ImmunoGen's Elahere saw a 33% reduction in mortality risk compared to chemotherapy - the first time an overall survival benefit had been achieved in chemoresistant ovarian cancer. AbbVie said it expects to complete the acquisition by mid-2024.

Conversely, Akero Therapeutics weighed on performance. The biotech firm is developing efruxifermin for non-alcoholic steatohepatitis (NASH), a fatty liver disease that affects over 10 million adults in the US and is a leading cause of liver failure. The company reported phase 2 data in the most severe NASH patients and failed to hit statistical significance on the main endpoint, in this case for fibrosis reversal. Despite achieving statistical significance on other disease markers and prior trials that prove the drug's benefit in moderate NASH patients, investors beat a retreat. We believe this had a lot to do with the recent perception that GLP-1 receptor agonists will crowd out the rest of the NASH market, which is misguided, in our view.

Sarepta Therapeutics was another detractor. We have been long-term holders of the company, a leader in the field of Duchenne muscular dystrophy with a marketed exon-skipping franchise approaching \$1 billion in sales and a novel gene therapy, Elevidys, that could be gamechanging for patients. The process of bringing Elevidys to market has had its ups and downs. In June, the US Food and Drug Administration (FDA) granted accelerated approval for four and five year olds, pending a confirmatory trial. In October, that trial missed on its primary endpoint, although it did show benefit on multiple key secondary endpoints. As such, the FDA could permit Elevidys to stay on the market and even allow a broader indication given the clinical benefits observed and high unmet medical need.

Manager outlook

Following a sharp sell-off, biotechnology stocks rebounded in the final months of 2023, benefiting from optimism the

rate-tightening cycle in the US was coming to an end. Positive clinical data and a surge of M&A activity also boosted investor sentiment, which in our view could continue to propel biotechnology stocks in the new year.

We believe the low valuations (at the time of writing) are attractive. As Treasury yields climbed in 2023, markets punished biotech firms that failed to meet clinical milestones or fell short in other ways. While some industry rationalisation was arguably needed - the sector saw a surge of new biotech companies funded during the pandemic, many without proof-of-concept data - we feel many valuations were pushed too low.

At the same time, innovation has been accelerating, with the FDA approving a record 73 new therapies in 2023. Many of these drugs target large disease categories (such as obesity, autoimmune disease, cancer and Alzheimer's), that could represent major new product cycles and drive revenue growth for the next decade. We expect no shortage of additional data readouts and approvals in 2024.

M&A activity has also picked up in recent months and could maintain momentum as biopharma firms, typically flush with cash, seeks to replace blockbuster products losing patent protection in the coming years. Growing market opportunities, including GLP-1s (for diabetes and obesity), gene editing, antibody drug conjugates, radiopharma and cell therapy treatments for autoimmune diseases, could also tempt biopharma companies to break out their checkbooks. In short, we believe the set-up for biotech is compelling heading into 2024. We feel that M&A, innovation and attractive valuations combine to offer a good investment opportunity over the year ahead.

Investment policy

The Fund invests at least 80% of its assets in shares (equities) and equity-related securities of companies, which are biotechnology or biotechnology-related, of any size, including smaller capitalisation companies, in any country. The Fund may also invest in other assets including bonds (including convertible bonds), preference shares, cash and money market instruments. The investment manager may use derivatives (complex financial instruments) with the aim of making investment gains in line with the Fund's objective, to reduce risk or to manage the Fund more efficiently. The Fund is actively managed with reference to the NASDAQ Biotechnology Total Return Index, which is broadly representative of the companies in which it may invest, as this forms the basis of the Fund's performance target and the level above which performance fees may be charged (if applicable). Investment strategy

The investment manager looks to identify innovative biotechnology companies addressing high unmet medical needs and trading at a significant discount to their intrinsic value. The team understands that success of drug development is binary in nature, creating wide disparities between winners and losers. The investment process leverages proprietary statistical models to analyse the probability of a company's success, focusing on products they believe can overcome the rigours of clinical development. Additional tools such as physician surveys, prescription models and scenario simulations attempt to more accurately predict commercial viability.
