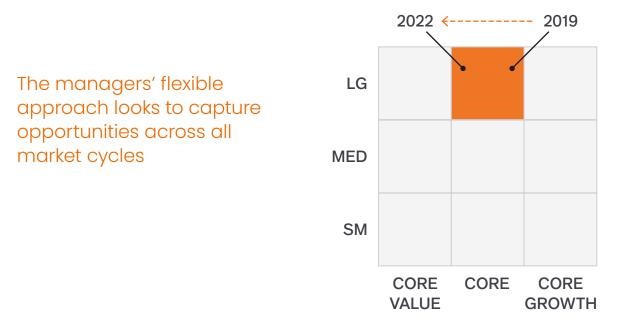
#### Dynamic investment approach
