Dear Shareholder,

We are writing to you as a Shareholder in one or more of the Company's funds (each a "Fund" and collectively the "Funds"). Unless otherwise stated, defined terms used herein bear the meaning attributed to them in the Company's latest Hong Kong offering documents (comprising the Prospectus, the Hong Kong Covering Document ("HKCD") and the relevant Product Key Fact Statements ("KFS"), collectively the "Hong Kong Offering Documents").

RE: Amendments to Reflect Requirements under the Revised Code on Unit Trusts and Mutual Funds

#### A. Background

The Company and the following Funds are authorised by the Securities and Futures Commission in Hong Kong ("SFC") and hence are subject to the applicable requirements under the Code on Unit Trusts and Mutual Funds ("Code") issued by the SFC. The Code has been revised.

## 1. Enhancement of disclosures on net derivative exposure

The HKCD and the KFS of the Funds have been amended to include disclosures on the expected maximum net derivative exposure arising from derivative investments. The net derivative exposure of each Fund is calculated in accordance with the requirements and guidance issued by the SFC, which may be updated from time to time.

The net derivative exposure of each Fund is as follows:

- 2. Other Amendments other amendments and enhancement of disclosures in the HKCD to reflect the requirements of the revised Code including the following:
  - enhanced disclosures on fair value pricing to reflect the requirements under the revised Code that any fair value adjustments shall be conducted in consultation with the depositary of the Company;
  - (b) amendments on transactions with connected persons and soft dollars arrangements to reflect the requirements under the revised Code;
  - (c) enhancement of disclosures relating to investment in debt instruments with loss-absorption features; and



 (d) other miscellaneous, administrative, clarificatory, general updates and enhancements of disclosure.

Please refer to the revised Hong Kong Offering Documents for further details of the Changes.

### C. <u>Implication of Changes</u>

The Changes will not result in any material change to the investment objective, investment policy and risk profile of each of the Funds. There will be no increase in the fees payable out of the assets of the Funds as a result of the Changes. The Changes will also not result in a change in the manner in which the Company and the Funds currently operate or are being managed. Accordingly, no action is required by you.
