Term

Objectives

The Fund aims to provide capital growth over the long term. Performance target: To outperform the S&P 500 Index by at least 2% per annum, before the deduction of charges, over any 5 year period. The Fund invests at least 80% in shares (also known as equities) of companies, of any size, including smaller capitalisation companies, in any industry, in the United States. The Fund may also invest in other assets including companies outside the United States, cash and money market instruments.
