## Janus Henderson Horizon Fund – Global Natural Resources Fund (the "Fund"): Correction to the Performance Target stated in the Prospectus

Dear Shareholder,

We are writing to inform you that, as part of our ongoing review of our products and services, we have discovered a clerical error in the Fund's Performance Target disclosed in the Prospectus. All other references to the Fund's Performance Target, including references in the Key Investor Information Documents ("KIIDs"), factsheets and on the website, are correct.

# Please note that since this correction is due to a clerical error, there is no impact on the way the Fund is managed or the Fund's risk profile. You do not need to take any action in response to this letter.

We will update the Prospectus at the earliest available opportunity to correct this and align the Prospectus disclosure with what is already stated in the KIIDs, factsheets and on the website. Details of the correction are outlined below: -

Incorrect Performance Target, as currently disclosed in the Prospectus	Correct Performance Target, as disclosed in the KIIDs, factsheets and on the website
	To outperform the S&P Global Natural Resources Accumulation Index by <u>2.5%</u> per annum, before the deduction of charges, over any 5-year period

The Fund's Performance Target has always been to outperform the S&P Global Natural Resources Accumulation Index by <u>2.5%</u> (and not by 3% as presently disclosed in the Prospectus).

We sincerely apologise to our Shareholders for any inconvenience caused and have strengthened our internal processes to reduce the risk of future clerical errors.
